Managing Director's Report

The Executive Team discussed the business assistance recovery efforts in which the RA+BP is engaged. The RA+BP is offering grants towards Tech support, including but not limited to: logo and branding; Website improvements; and Search Engine Optimization. Trustees will be consulted if additional funds need to be allotted.

The RA+BP is assisting the City with advertising of the pavilions that were constructed on Cherry Street and Lewis Street. The architectural plans for similar structures at different sizes, will be available to all businesses that are interested in constructing something similar on their property. The City will waive application and inspection fees.

The City and RA+BP are creating small outdoor events and activities to encourage the community to come out in the cold weather.

The RA+BP is working with a Research and Marketing class at Seton Hall University and a Public Relations and Marketing class at Kean University. The final presentation information will be shared with the Board.

City Beautification efforts continue with season planting, research into bike racks, new lamppost banners for *The Grands*, and improved landscaping at the Paseo.

The addition of Julio Mercado, a dedicated maintenance person for the downtown has been a significant improvement to the streetscape.
