#### **Meeting Summary:**

#### Managing Director's Report

Managing Director Williams provided an update on the Rahway CARES 2.0 forgivable grant program: 66 businesses awards complete; 36 partial awards funded. The rest are still pending and need to present paperwork. Grant's final deadline is Monday 3.15.2021. Williams will update the Board on the final numbers.

January Soup Stroll was very successful and the RABP intends to make it an annual event. Restaurants reported seeing many new patrons attending the Soup Stroll and acquired new customers that they attribute to the Stroll.

Managing Director Garcia Phillips updated the Trustees on the ongoing plans to improve East and West Grand and rebrand the entire area "The Grands". Physical improvements include the planters, improved lighting with permanent decorative lamp posts, sidewalk improvements and lamppost banners that contain the new branding. Schwartz suggested we incorporate the RA+BP logo as a way to communicate the source of the improvements. Vice President Larry Fishman entered the meeting at 6:47pm.

#### New Business

President Schwartz proposed moving the 2021 annual meeting from March to May for the purpose of allowing the Nominating Committee time to vet potential candidates. The annual election of officers will take place at this time. Nomination Committee Members are Schwartz, Dobrowolski and Garcia Phillips.

The Managing Directors illustrated the new concept for the Taste of Spring 2021. Utilizing a Passport, uniquely created for this event, patrons pay \$5 for the Passport and then visit participating establishments on the day and time they are participating. Taste "travelers" pay \$5 for the featured food or drink offering. Thirty eight establishments are participating, twenty nine of which are located in Rahway.

The Executive Team reported on upcoming and ongoing events such as Munch Madness, Rahway's Own and Rising Star Nominations, Culture Crawl Music Series, and Culture Crawl Arts and Music Festival. As well as other events the RA+BP have been asked to collaborate including Rahway River Watershed Association's Water Festival and a Large Scale Chalk Art project. The RA+BP with assistance from the City, is applying to become a member of *Main Street New Jersey*. The City hired grant writers from the Aubrey Group to prepare the application. While the focus is The Grands, all of the SID will benefit from the designation.

"Main Street New Jersey is a Main Street America<sup>™</sup> Coordinating Program and works with communities in NJ providing on- and off-site technical assistance and training in downtown revitalization and management. The program helps municipalities improve the economy, appearance and image of their central business districts through the organization of local citizens and resources."

VP Fishman asked if the Aubry Group will continue to write grants for the RA+BP. Managing Director Garica Phillips reported that both parties would consider working together again, however, nothing has been formally discussed or established.
